Dear Judge Castel,

I am honored to write this letter for a very special and important person to me. I am the General Manager of Cili Restaurant in Las Vegas, Nevada. I have worked for Mr. Walters since October 1998; I started as a beverage cart attendant and worked my way up to my current position as General Manager of Cili Restaurant. I was one of the only women in management in the golf business in Las Vegas; he has continued to promote me on merit and experience. I am very grateful for the opportunities Mr. Walters has given to me. He rewards great, loyal employees and promotes from within his companies.

On a personal note, my dad passed away 2 years ago, and Mr. Walters was the first phone call I had from anyone the morning after it happened. He also donated money in my father's name to Nathan Adelson Hospice. The gesture showed immense compassion for my family at a very difficult time. I was very appreciative for the kindness of Mr. and Mrs. Walters.

All of us at Bali Hai and Cili are a close family; we all take care of each other. That starts from the very top. Mr. Walters gives us the ability to help all the employees when in need. I have seen him help in many ways over the last 19 years. He helped Raul Arroyo when his daughter was killed in car accident and they couldn't afford a burial for her; without question the Walters took care of it. [REDACTED]

All of us here are also very proud of the contributions he has given to our community. As one example, Cili held a lunch for 250 guests for Nevada Legal Services last November. Mr. Walters was here that week and in his office, he wasn't aware of the event that was taking place; but when he found out what the event was for, he immediately offered to pay for the lunch so the additional funds they raised could help more people in need with their legal fees. The group was absolutely overwhelmed with his generosity. Mr. Walters also gives Cili management the authority to donate space, food and golf for charities close to all our hearts. For many years I had the Las Vegas Basset Rescue here at Cili, this was a charity important to me. He donated the space and some of food, this raised money to help the homeless and sick basset hounds. These are just some of the many charities he contributes to. The general public doesn't always get to hear about all the amazing things he does for the people and animals for the city of Las Vegas.

Mr. Walters owned the Royal Links Golf Club for many years, and it was one of the first properties where I worked for him. He sold the property this year and it was very important for him to keep his staff working when the new company took over. He actually accepted an offer for \$600,000 less for the

property, due to the fact that this offer included an agreement that required the new owner to keep the entire staff of the Royal Links working at the Club after it was sold. All the employees didn't end up staying at Royal Links, but even then Mr. Walters found spots for them at Cili or Bali Hai. It just shows that his employees are considered family.

Mr. Walters will always have a special place in my heart; he has been there for me for my entire adult life. I know many of us feel very grateful to have him in our lives.
